Office Order 01/2023 (Student Discipline Policy)

Issued from the Office of Dean Students' Welfare after approval from Director Sir for your kind information please.

Objective of The Policy

To create a safe and conducive learning environment, uphold standards of behavior and academic integrity, and provide a framework for addressing misconduct while fostering personal growth and development among students.

In ABESIT Group of Institution, the primary focus is on effective governance of academic and administration. We believe that a positive and productive learning environment prevails, enabling students to strive for excellence. When students know what is expected of them, they are more likely to focus on their studies and engage in constructive activities. It sets the standards for how individuals should treat one another, fostering a respectful and inclusive campus culture.

To address indiscipline issues, ABESIT Group of Institution has formed a discipline policy that is very transparent, firm and will be consistently applied. This policy is including provisions for counseling, Undertaking, Warning, or other forms of support to help students address underlying issues that contribute to misconduct. This discipline policy will ensure us about the sanctions and consequences are managed properly and dealt within a fair and unbiased manner for maintaining trust within the college students' community.

Discipline Rule and Procedures

- 1. Institute's Proctorial Board and their Responsibilities are mentioned at **Annexure -1**.
- 2. Details of various acts of indiscipline along with corrective actions for each case are given at **Annexure -2**. In this, corrective action describes the steps to be taken to deal with each situation reasonably and help the concerned students to improve their standards of conduct.
- 3. In case of any act of indiscipline is noticed, the concerned faculty/ any office bearer will report to department proctorial board member/ Dean SW. Department proctorial board member will prepare incident report (Annexure 3) with the help of concerned faculty/ office bearer and submit to Dean SW. Based on that, respective HoDs/other Function Heads, Dean SW, and Department proctorial board member jointly will take suitable decision. Further, Dean SW will discuss all with Director Sir for approval.



- 4. Formats in respect of undertaking by students (**Annexure -4**) & parents (**Annexure -5**), warning letter (**Annexure -6**) and counseling letter (**Annexure -7**) are attached and if needed given to concern students, afterward.
- 5. All departmental proctorial board members are expected to maintain the record of every communication regarding indiscipline act within the department and submit the same fortnightly to the office of Dean SW on regular basis.
- 6. This policy will empower all faculty & staff to maintain discipline in the classroom and the campus.
